International students who wish to pursue their education in the United States must submit their official High School or GED transcript, as well as all college transcripts by the application deadline. All international transcripts must be evaluated\* by an approved evaluation service and sent directly to: *Albany Technical College, Office of Admissions, ATTN: International Student Admissions, 1704 S. Slappey Blvd., Albany, GA 31701.*
